The SSCI Environmental Benchmark Criteria will define minimum requirements for how environmental certifications should operate. In demonstrating alignment with these Criteria, standards will achieve SSCI Recognition and join a list of trusted, credible standards. This process will help ensure the industry has a clear and consistent set of expectations to follow and help build trust in environmental certifications. **We need your help to make this process successful!**

As we develop the Benchmark Criteria for environmental standards, we want to ensure that we cover all the essential areas required for a comprehensive environmental certification framework. Therefore, we invite you to review our proposed structure and provide feedback on whether we are covering all the essential areas. We also welcome your recommendations for the benchmarking process and any other stakeholders who should be involved in the process. We understand that some stakeholders may be concerned about the minimum requirements being too stringent or restrictive; however, we assure you that the process will be collaborative, and we will take all feedback into account to develop realistic, effective, and achievable standards.

By participating in development of the Benchmark Criteria, you will contribute to a more **transparent**, **credible**, **and sustainable environmental certification system**. Your input will help ensure that the SSCI recognises the best environmental certifications and sets a bar for our industry that meets the expectations of all stakeholders.

The SSCI Benchmark process consists of six steps, starting with an application to the SSCI team. The process is designed to last 12 months.



About the Draft Environmental Benchmark Criteria

You are invited to provide your feedback on our draft Benchmark Criteria for environmental sustainability standards working in the Manufacturing and Processing; Primary Production; and Forestry sectors.

Benchmark applicants will be evaluated against the SSCl's Environmental Benchmark Criteria and the SSCl's Scheme Management Criteria.

The Environmental Benchmark Criteria will define the key environmental sustainability topics that standards should cover. The topics include:

- Environmental Management System
- Legislation and Transparency
- Pollution Prevention and Management of Potentially Hazardous Substances
- Major Incident Prevention and Management
- Soil Preservation
- Energy Use
- Water Use
- Emissions to Air
- Wastewater
- Waste
- Land Use and Biodiversity
- Grievance Mechanisms

The public consultation will run on the SSCI website from 30th May to 30th June 2023. We invite you to review the draft Environmental Benchmark Criteria and send your comments by the deadline to ssci@theconsumergoodsforum.com.

All SSCI Benchmark applicant schemes will be evaluated against the SSCI Scheme Management Criteria in addition to the Environmental Benchmark Criteria. While the Environmental Benchmark Criteria will define the topics that standards should cover, the Scheme Management Criteria ensure schemes operate ethically and responsibly.
